

Group Last Expense Cover

Funeral insurance plans provide for the payment of fixed amounts on the death of any member to cater for the costs of arranging the funeral. Such plans provide cover for the following members: -

- Principal – member of company/association
- Spouse of the member
- Children of the member
- Parents of member
- Parents in law of the member

The Funeral Plan Cover amounts are as follows: -

Conditions: -

- Main Member/Spouse: – Minimum Entry Age : 18 years
– Maximum Entry Age : 60 years
– Maximum Coverage Age : 90 years
- Children – Minimum Entry Age : 3 Months
– Maximum Coverage Age : 18 years/25 years for fulltime students
- Parents/Parents-In-Law – Maximum Entry Age : 70 years
– Maximum Coverage Age : 90 years
- Waiting Period is 3 months for illness related deaths only (no waiting period on accidental death)
- Minimum number of members required is 20 members
- Minimum population of whole scheme – 50 members
- On death of a member the benefit will be paid within 48 hours on receipt of claim documentation
- No Exclusions other than active war participation.
- 24 hour worldwide cover

Funeral Plan Policy Requirements

To enable the placement of the Funeral Plan Cover, Jubilee will require the following information and/or documents: –

- Group Profile i.e. Registered name and activity – captured in the Group Funeral Proposal Form
- Members to be covered and amounts of cover per member including the following details: -
 - Full names of the members (main, spouse and children) indicating the dates of birth
- Claim documents include the following: -
 - Duly completed Claim Form
 - Original Burial Permit
 - Copy of National ID for adults
 - Copy of Birth certificate for children
